It is with great pleasure that we announce a major milestone: **Malta has been selected as the host of the EBRA Annual Conference 2026**. This announcement was made during this year's EBRA Annual General Meeting held in Milan, Italy.

EBRA (European Business Register Association) is a network of business registry experts dedicated to improving the management and operation of business registers across Europe. With 43 member registries, EBRA plays a pivotal role in fostering collaboration among national registries. Hosting this prestigious event will allow Malta to promote stronger ties between European registries and encourage meaningful collaboration.

The Malta Business Registry (MBR) also actively participated in several outreach events aimed at showcasing its services and promoting better public understanding of its role. Notably, the **Public Service Expo** served as an excellent platform to engage with students and members of the public. The event

highlighted the importance of maintaining up-to-date business registry information and how the MBR plays a role in everyday life.

Communication remains a top priority. In collaboration with the **Malta Chamber of Commerce**, we held a successful event focused on **BAROS**, MBR's online portal. The session enabled technical staff, practitioners, and directors to engage in open dialogue, address queries, and gain deeper insight into the portal's digital features.

A key update for all subscribers: **as of 16 July 2025**, amendments to the Companies Act will come into force, in line with **Legal Notice LN 92 of 2025**. These changes are designed to improve company reporting requirements to the Registrar and include the introduction of **two new statutory forms**, along with amendments to existing **Forms K and K(1)**, as reflected in the revised Forms Regulations – more information can be found in this newsletter.

It is clear that the MBR has evolved beyond being a simple registry – it is now a proactive institution working in the best interests of the Maltese jurisdiction. We encourage you to stay engaged, follow our latest updates, and be part of our future initiatives.




FAMILY BUSINESSES TRAINING SEMINAR




PUBLIC SERVICE EXPO 2025

INFORMATIVE NOTE PUBLICATION OF LEGISLATION

MAY 16 | 2025

AMENDMENT TO THE FORMS REGULATIONS

The Companies Act (Forms) Regulations (“the Forms Regulations”) are being amended by virtue of Legal Notice LN 92 OF 2025. The changes stem from the amendments affected to the Companies Act and to enhance the reporting made by companies to the Registrar in terms of the Companies Act. For these reasons the Forms Regulations will now incorporate two (2) new statutory forms and an amendment to the existing Forms K and K (1).

NEW FORMS:

Form F (3) – upon the appointment of an auditor in the cases stipulated in article 66(3) or article 151(9) of the Act, the company is to submit this new form to the Registrar, within 14 days from such an appointment. The form, indicating the appointed auditor’s name and warrant number, serves as to notify the Registrar of every auditor’s appointment taking place in a company. Failure to do so will result in liability of the company’s officers to administrative penalties, as applicable under article 151(6) of the Companies Act.

Form K (2) – following the appointment of a person by an order of the court or competent authority, as the company’s administrator, legal representative or as the person de facto responsible for the management and administration of the said company, the respective person is to inform the Registrar of such an appointment within 14 days. The same form is to be filed when such person is removed or resigns from such a role. The time-period to notify the Registrar in such cases is also of 14 days. No administrative penalties are being prescribed in such situations.

AMENDMENT TO EXISTING FORMS:

Form K and Form K (1) – to ensure legal certainty, the English version of the Form K is being amended. The term “legal representation” is being replaced with “representation” to remove discrepancies between the English and Maltese texts. Furthermore, the wording in relation to the directors’ consent and declaration in terms of law is being substituted and re-organised to reflect better reporting.

USER GUIDELINES:

One may access the [User Guidelines](#) which seek to guide the citizen and all stakeholders throughout the process. As part of the obligations to protect small and medium sized enterprises, the new Forms will only become effective following two (2) months from the publication of the Legal Notice.

JOINT MFSA AND MBR COMMUNICATION ON AVOIDING NAME SIMILARITIES BETWEEN SLPFs & INCORPORATED COMPANIES

MAY 28 | 2025

Reference to the Malta Financial Services Authority's (MFSA) [Circular](#), of the 12 February 2025, launching a framework for Collective Investment Schemes structured as Limited Partnerships without separate legal personality – Special Limited Partnership Funds (SLPFs).

As outlined in Section 6 of the said Circular, the SLPF framework is fully administered by the MFSA, which is responsible for both the approval of the Limited Partnership Agreement (LPA) establishing the SLPF and the Scheme's authorisation under the applicable regulatory framework.

Section 5 of the same Circular encouraged interested parties to ensure that the proposed name of an SLPF is not identical or too similar to the name of any existing commercial partnership registered with the Malta Business Registry (MBR), in line with Regulation 6 of the Investment Services Act (Special Limited Partnership Funds) Regulations.

In this regard, the MFSA and the MBR would like to further emphasise that it is considered undesirable to apply for the incorporation of a company by a name that:

- i. is already in use by an SLPF listed in the MFSA's Financial Services Register; or
- ii. includes the phrase or abbreviation "Special Limited Partnership Fund", "SLPF", or "S.L.P.F.", or any similar wording that, in the MBR's opinion may give rise to confusion.

Stakeholders are advised that whilst the acceptability of a company name will be assessed on a case-by-case basis, the MBR reserves the right to refuse the registration of companies by a name which is considered to be undesirable, pursuant to Article 70(4) (b) of the Companies Act.

Further to the above, stakeholders are reminded that all authorised SLPFs will be listed in the MFSA's Financial Services Register, which is accessible through [this link](#).

NOTICE

ATTENTION DIRECTORS & COMPANY SECRETARIES

MAY 30 | 2025

The Malta Financial Services Authority has made enhancements to its current regulatory framework for Company Service Providers (CSPs), which cover the provision of directorship and company secretary services.

Up until now, individuals acting as directors or company secretaries in no more than two involvements were not required to obtain authorisation from the MFSA. To gain greater oversight of this group and assess the potential risks they may pose to the jurisdiction, the new legislative framework now requires that such individuals submit a notification regarding the positions they hold.

ACTION REQUIRED

If you currently provide directorship or company secretary services to one or two client companies, make sure to **submit your notification to the MFSA by 16 July 2025**.
